

# **BOMA/Chicago Foundation Single Course Scholarship Application**

#### **PURPOSE**

The BOMA/Chicago Foundation Single Course Scholarship provides professional development and educational opportunities through financial assistance to individuals who may not otherwise be able to attend local Real Property Administrator (RPA) courses. The BOMA/Chicago Foundation's Single Course Scholarship program is designed to support commercial real estate professionals who aspire to earn the RPA designation, demonstrate financial need, and are dedicated to advancing within the industry and becoming leaders. The scholarship pays for one RPA class, valued at \$1,400.

#### **ELIGIBILITY REQUIREMENTS**

- 1. Individuals working in commercial property management are eligible to apply.
- 2. Applicants must have at least three years of commercial real estate experience by **the start date of the course for which the applicant is requesting scholarship funds.** 
  - a. \*Internships may be eligible to count toward the three years of experience. Please see the below note.

- 3. This scholarship opportunity is also available to individuals working for a Chicago office building in a capacity other than property management who are interested in transitioning to a property management career, including those who have or who are developing an understanding of important aspects of building operations (for example: security guards, janitorial staff, and building engineers).
  - a. For purposes of this scholarship, working "for" a Chicago office building includes employees of building contractors.
  - b. Applicants must have worked for a commercial office building for at least three years.
- 4. Applicants must be at least 21 years old.
- 5. No college degree or transcript is required.
- 6. Applicants do NOT need to be a BOMA/Chicago member.
- 7. Applicants must be able to describe financial need. If your current employer pays or reimburses you *for more than one* RPA designation class each calendar year, you are not eligible for this scholarship.
- 8. Submission of two references.
- 9. Applicants must submit a complete Scholarship Application form, with its requested attachments, by the deadline a minimum of two months in advance of the start date of the course for which the applicant is requesting scholarship funds.

#### \*Internship Experience Recognition

If you have completed a commercial real estate internship, you may apply to have the time spent in the internship count towards the required three years of experience for the Scholarship. Along with your application, please include one document that describes:

- 1. The dates of your internship(s).
- 2. The number of hours for each internship and whether the internships were full-time or part-time.
- 3. Your internship responsibilities and the skills you acquired.

The Foundation's Scholarship Committee or other appropriate body will determine whether an internship may count toward the required experience by comparing its length, contiguousness, recentness, and scope of work to typical full-time work experience. Applicants may be required to submit additional material to aid in this evaluation.

#### ELIGIBILITY FOR MORE THAN ONE DESIGNATION COURSE SCHOLARSHIP

A scholarship recipient who successfully completes a designation course paid by scholarship funds may choose to apply for **up to three single course scholarships at a rate of one course per calendar year** (scholarships cannot be approved for consecutive courses).

To apply for a second or third scholarship, the applicant must submit a letter from BOMI International confirming that the applicant passed the previous course exam.

#### APPLICATION DEADLINES & ONLINE FORM PROCESS

Scholarship applications are due a **minimum of two months in advance of the start date of the course** for which the applicant is requesting scholarship funds. This application is the Word document format of the <u>mandatory online</u> application you must submit in order to be considered for this scholarship.

To aid you in preparing your submission, the questions required for the online application are included below. Before submitting your online application, we suggest that you:

- 1. Answer all questions in the Word document and spell-check your answers. You can then copy and paste your information into the online form.
- 2. Have all your attachments ready. All attachments within the application are marked with an asterisk (\*).

#### TWO REFERENCES REQUIRED

The <u>two references</u> for each applicant must also be <u>filled out online</u>. Please direct your references <u>to this website</u> to complete the online reference form at least two months in advance of the start date of the course for which the applicant is requesting scholarship funds. The reference form is located on pages 6 and 7 of this document.

#### REQUIREMENTS FOR MAINTAINING SCHOLARSHIP ELIGIBILITY

- 1. The scholarship recipient must complete enrollment in their course within the same calendar year of the scholarship award.
- 2. Should the recipient not pass a course funded by the scholarship, the recipient will be responsible for all costs associated with reexamination. (Recipients must pass all preceding courses and subsequent courses.)
- 3. The recipient agrees to reimburse the BOMA/Chicago Foundation for any funds that are subsequently reimbursed by their employer.
- 4. If a previous Single Course recipient applies for another scholarship, this recipient must have passed the exam for the previous class for which they received the Single Course Scholarship for.

If the above requirements are not met, the BOMA/Chicago Foundation reserves the right to revoke the recipient's scholarship.
